- A. Buyer fails to complete the purchase of the dog or
- B. Buyer fails to pay the balance of the purchase price with in 10 days after agreed upon delivery date. At which time seller has the right to offer the puppy for sale to another family.

In the event the dog is not available due to sickness, death, or any other circumstance due to the fault of the seller, Buyers deposit will, at buyers option, be either refunded, or transferred to next similar puppy. <u>In the event no other puppies are available with in 1 year, deposit will be refunded.</u>

Buyers Responsibility

- A) Buyer will maintain dog in good health, including keeping up with parasites, internal and external, keeping teeth cleaned yearly. Once a year vet checkups.
- B) Keep dog in the home. Dog will not be chained outside or stay in cages all day. Provide a fenced yard.
- C) Provide clean water and quality food at all times.
- D) Buyer will keep coat clean and always maintained.
- E) Buyer will not sell, release the dog or offspring of dog to pet shop, puppy mill, retail store, dog dealer, animal testing facility.

Sellers Responsibility and Health Guarantee

- A) The puppy/dog has received the appropriate vaccinations and worming as noted in the Health Record. The dog has been found to be in good health, free from diagnosable illness, and or defects at time of sale.
- B) Buyer agrees to have the dog/puppy examined by their veterinarian within three (5) days, excluding Sundays and holidays, of the date in which the puppy is received.
- C) The health of the puppy/dog is guaranteed for <u>3 years</u> against congenital defects, (born with), causing premature death of the puppy/dog: this does not include cherry eye, injury from accidental fall or jumping, accidental deaths, parasites, poisoning, negligence, or incorrect bites, extra teeth.
- D) The Breeder/seller reserves the right to request a second diagnosis from our own veterinarian to confirm the first diagnosis.
- E). In the event the puppy/ dog is found to have life-threatening health condition, heart defect, severe liver condition, or other conditions that will cause death of the puppy, a refund of the purchase price or offer to transfer the amount to another similar puppy can be made to the buyer. The puppy must first be surrendered to the seller/breeder before refund can be made. Buyer responsible to deliver of puppy.
- F) Any procedures or surgeries are the responsibility of the buyer unless first discussed with seller.
- G) Puppy is on a spay/neuter contract, unless otherwise agreed upon. Puppy must be spayed between 6-10 mth of age. Spaying your puppy will prevent future mammary cancer later in life in females.
- J) The Seller does not guarantee the dog against health-related problems or deaths caused by vaccines, heart worm prevention, flea/tick medications, parasites, spaying/neutering, or other non -life threatening conditions are not covered in this agreement. All vet fees are the responsibility of the buyer.
